**THIS AGREEMENT** made the 26 day of February 2015

**BETWEEN:**

1. **THE BROADCASTING AUTHORITY OF IRELAND**  
of 2-5 Warrington Place, Dublin 2

(hereinafter called "the Authority")

and

2. **TV3 TELEVISION NETWORK LIMITED**  
having its registered office at Riverside 1, Sir John Rogerson's Quay, Dublin 2

(hereinafter called "the Contractor")

**WHEREAS:**

- A. The Broadcasting Commission of Ireland and the Contractor entered into the Renewed and Varied Contract on 10<sup>th</sup> September 2009.
- B. Under Section 176 of The Broadcasting Act 2009, all rights and liabilities of the Commission under the Renewed and Varied Contract transferred to the Authority.
- C. The Authority, having been so requested, has agreed to enter into this Supplemental Contract with TV3, with a view to varying the terms of the Renewed and Varied Contract.



## **SECTION 1.0 – OPERATIVE PROVISIONS**

### **1.1 Variation**

In exercise of its powers and pursuant to 10.12 of the Renewed and Varied Contract, the Authority hereby varies the Renewed and Varied Contract in the following manner, and the Contractor hereby agrees to such variation.

1.1.1 In clause 1.1 of the Renewed and Varied Contract the following definition shall be inserted:

“**TV3 +1** A one-hour time-shifted re-broadcast of TV3”

1.1.2 The following clause shall be inserted as 2.1.3 “provide TV3 +1 by means of inclusion as part of a multiplex and / or by means of an electronic communications network including a satellite network, a MMD system, a fixed or mobile terrestrial network, a cable television network, or an internet protocol television network

### **2.1 Confirmation**

2.1.1 In all other respects the Authority and the Contractor hereby confirm the Renewed and Varied Contract.

2.1.2 This Supplemental Contract is supplemental to the Renewed and Varied Contract and the two contracts shall be read together and construed as one contract.
